Notice Concerning Additional Acquisition of Nippon Hotel & Residential Investment Corporation's Investment Units by APA Holdings Corporation

APA Investment Management Co., Ltd. ("APAIM"), APAIM to which Nippon Hotel & Residential Investment Corporation ("NHR") entrusts the management of its assets, has received notice today from APA Holdings Co., Ltd. ("APAH"), which has entered into a sponsor support agreement with NHR, that APAH will acquire additional NHR investment units (the "Additional Acquisition"), and hereby announces the details as set forth below.

1. Details of the Additional Acquisition Notified by APAH

(1) Total number of	A total of 4,000 units at maximum. However, if during the acquisition		
investment units to be	period, the total acquisition amount reaches the initially set amount, the		
acquired	maximum number of units may not be acquired.		
(2) Acquisition period	Scheduled to be 50 business days at maximum from September 2,		
	2024. However, the acquisition may be completed prior to the end of		
	the above period, in case the number of units acquired reaches the		
	maximum number, for example.		
(3) Acquisition method	APH will acquire the NHR investment units through market purchases		
-	based on entrustment of purchases to a brokerage firm.		

2. Purpose for the Additional acquisition

By APAH acquiring additional NHR investment units, NHR's unitholders will be aligned with the interests of the APA Group (note), and this is expected to provide sponsor support that will lead to the medium- to long-term growth of NHR.

(Note) A collective term for APAH, which holds all of APAIM's issued shares, and its consolidated subsidiaries. The same applies below.
